VII. New Business

- i. Hagerstown Fire Department (HFD) / Deana Pelton (Fire Marshal's Office)
 - i. Permanent and/or homemade outdoor grills, fireplaces or barbeques must be approved by the fire Marshal's Office.
 - ii. **ONLY** approved firepits (purchased at a commercial retail store) or tiki torches should not be used within 15ft of structures or combustible materials.
 - iii. For more information, please review brochure that is located on our community website and/or the quarterly newsletter that will be sent out towards the beginning of May 2024
 - a. Safety Tips:
 - i. Keep water source of fire extinguisher nearby
 - ii. Avoid using firepit and/or grill on a windy day
 - iv. Fireworks (shot up within the air) are illegal at any time. Authorities will be contacted and fines will be received
 - a. \$500.00 fine for each firework (ie. A box of 10 – the owner will be fined a total \$5000.00)
- ii. Jim Bender (City Engineer) Discussion on speed humps along Nittany Lion Circle (NLC)
 - i. Petition of study for future precautionary measures to assist with constant speeding within our community
 - a. Speed Control – 3 and/or 4 way stop
 - ii. Storm Drain Erosion (2 drains)
 - a. Located adjacent to Yellow Jacket and behind homes on NLC / Hurricane Court
 - i. Until fix is in place and for precautionary measures, the board will install orange mesh around both drains and no one is permitted around drains until issue is resolved
 - iii. Side Walk Uneven (several locations around the community)
 - a. Issue was revisited to have temporary markings around these locations until issue is corrected by the City
 - iv. Enhance Lighting / Security Cameras within Overflow Parking Lot
 - a. Waiting for updates from the City regarding next steps
